SEASON PASS APPLICATION 2008-2009

All season passes at Sleepy Hollow offer unlimited skiing, boarding and tubing during the 08-09 winter season (regularly scheduled dates) and are valid through March 16, 2008. Season passes are non-transferable and may only be used once per day for the pass holder's all area, all day ticket. Use of the pass holder's ticket by someone other than the pass holder may result in loss of season pass privileges.

Everyone must be wearing a "ticket of the day." Simply, show your season pass at the designated ticket counter each time you come to receive your daily ticket. If a pass holder's daily ticket is lost or stolen, it will not be replaced. If a pass holder's season pass is lost or stolen, it can be replaced by paying a \$10.00 handling fee.

Family rates apply to parent(s) and their immediate children 18 years old living at home or their dependent college students under 22 years. A family is further defined by all members being listed on the same IRS Form 1040.
