## All Season Activity Pass – Year Round Fun For One Low Price!

### SEASON PASS APPLICATION 2009-2010

All Season Activity Passes (ASAP) at Sleepy Hollow are now good for the whole year! They now include:

- \* **Unlimited skiing and snowboarding** (1 per day per pass)
- \* **Unlimited tubing after 5 PM**
- \* **One Fun Pass daily between Memorial and Labor Day** (includes 1 round of mini-golf, 1 climbing wall ticket, 1 batting cage token, 1 ride on the Wizzer, hot shot basketballs, and sand volleyball (unless league is in play))
- \* **Unlimited par-3 golf in season** (roughly late April – early October) *~does not include driving range~*
- \* **Unlimited camping and one canoe trip per year** (excludes holidays and Iowa State Fair.
- \* **One ticket to the Haunted Scream Park** (not valid on Saturdays)
- \* **1/2 price go-kart and 1/2 price bumper boat tickets** (1/2 price fee defers cost of fuel and maintenance)
- \* **A birthday party for you and 5 of your friends with seasonal activities** (either a Do-It-All Pass or a Tubing ticket for 6), a large one-topping pizza and 1 pitcher of pop – *Do –It – All includes go-karts!*

These passes are valid one year from the time of purchase. Passes are non-transferable and may only be used once per day for the pass holder. Use of the pass holder's ticket by anyone other than the pass holder may result in loss of pass privileges.

Everyone must be wearing a "ticket of the day" during winter activities. Show your season pass at the designated ticket counter each time you visit to receive your daily ticket. If a pass holder's daily ticket is lost or stolen, it will not be replaced. If a pass holder's season pass is lost or stolen, it can be replaced by paying a \$10.00 handling fee.

Family rates apply to parent(s) and their immediate children 18 years old living at home or their dependent college students under 22 years. A family is further defined by all members being listed on the same IRS Form 1040.

**Exclusions:** Halloween tickets not valid on Saturday nights. Camping is valid from Memorial Day weekend – August 10<sup>th</sup>. State Fair camping is available but not covered with your season pass. Camping not valid with season pass July 1 – 6, but it is available. Camping is free, but hookups are \$10. Canoeing is valid for one trip down the DSM River between Memorial Day – Labor Day, weather dependant. Paying groups will always be served first with canoes. Reservations are required for canoeing and camping at least 10 days in advance. Birthday parties must be scheduled at least 3 days in advance. Birthday parties may be larger than 6 people, - you are responsible for additional tickets and food. Unlimited golf portion does not cover the cost of additional rentals, such as pull cart, motorized cart or clubs. The driving range is not part of the season pass. All winter lift tickets are covered, however, rental is not a part of the season pass. You may bring your own snow equipment. You may bring your own clubs and bats. You will be added to our mailing list and you will receive additional discounts, conditions and promotions. At any time you may ask to be removed from our list, but honestly, if you save extra money, why would you? Finally, enjoy your All Season Activity Pass!

I desire to participate in the activities offered at Sleepy Hollow Sports Park. I understand those activities to include, but not be limited to ALL SEASON ACTIVITY PASS (ASAP). I understand that these activities at varying times range from recreational to competitive. It is my intent to participate in the activities at the level being offered on this date.

I am aware and fully understand that (ASAP) can be very dangerous. They involve the risk of damage, serious injury and death, both to me and to others. I understand there are many potential causes for property damage, serious injury and death at Sleepy Hollow Sports Park, including negligence of Sleepy Hollow Sports Park, its owners, employees, volunteer staff, rescue personnel, and equipment as well as my own negligence and the negligence of others.

In consideration of being permitted to participate in the activities (ASAP) offered at Sleepy Hollow Sports Park I hereby agree to release, waive, discharge, and covenant not to sue Sleepy Hollow Sports Park, its owners, agents, employees, or rescue personnel as well as any equipment manufacturers and distributors involved with the Sleepy Hollow Sports Park facilities from all liability from any and all loss or damage I may have and any claims or demands I may have on account of injury to my person and property or the person and property of others, including death, arising out of or related to the activities offered at Sleepy Hollow Sports Park, its owners, agents, employees, volunteer staff, equipment manufacturers, distributors or otherwise.

In consideration of being permitted to participate in the activities (ASAP) offered at Sleepy Hollow Sports Park I assume full responsibility for any risk of bodily injury, death, or property damage arising out of or related to the activities offered at Sleepy Hollow Sports Park. I assume full responsibility for any risk of bodily injury, death or property damage arising out of or related to the activities offered at Sleepy Hollow Sports Park whether caused by the negligence of Sleepy Hollow Sports Park, its owners, agents, employees, volunteer staff, equipment manufacturers, distributors or otherwise.
