Rules for SLEEPY HOLLOW/PARK & REC Corn Toss:

1. Teams are made up of two people, which will line up on the same side of opposing boards, directly across from each other.
2. Each team will have 4 bags of one color.
3. All 8 bags begin at one end.
4. A coin flip or rock/paper/scissors determines which team has honors. Team with honors chooses the bags & side of board.
5. The team who has honors throws first. **DO NOT START THROWING UNTIL THE START OF THE ROUND IS ANNOUNCED.**
6. A player may throw from anywhere behind the front of the board they are throwing from.
7. Alternate throws between the two opponents until all 8 bags have been thrown.
8. If a bag hits the ground then bounces up onto the board, remove that bag for it does not count.
9. Players will add up all the points scored (no cancels) and will be logged on the scoresheet before the bags are removed.
10. Teams will get 1 point for each bag on the board and 3 points for each bag in the hole.
11. If any team reaches 21 before time is up, and has the lead, the game is over. If teams are tied after a round at 21 or more, they will continue to throw until there is a leader after a round is finished.
12. If no team is at 21 when time is called, the teams will finish that round. Whatever team is ahead after the final round wins. If it is tied, an additional round will be thrown until there is a winner.
13. The winning team should circle the winner and return the scoresheet to the command area.
14. The top 2 teams from each night will return the championship round. The championship round will involve "cancelled" points with the winner at 21 (no time limits).

I am aware and fully understand that (CT) can be very dangerous. They involve the risk of damage, serious injury and death, both to me and to others. I understand that there are many potential causes for property damage, serious injury and death at Sleepy Hollow Sports Park including negligence of Sleepy Hollow Sports Park, its owners, employees, volunteer staff, rescue personnel, and equipment as well as my own negligence and the negligence of others.

In consideration of being permitted to participate in the activities (CT) offered at Sleepy Hollow Sports Park I hereby agree to release, waive, discharge, and covenant not to sue Sleepy Hollow Sports Park, its owners, agents, employees, or rescue personnel as well as any equipment manufacturers and distributors involved with the Sleepy Hollow Sports Park facilities from all liability from any and all loss or damage I may have and any claims or demands I may have on account of injury to my person and property or the person and property of others, including death, arising out of or related to the activities offered at Sleepy Hollow Sports Park, its owners, agents, employees, volunteer staff, equipment manufacturers, distributors or otherwise.

In consideration of being permitted to participate in the activities (CT) offered at Sleepy Hollow Sports Park I assume full responsibility for any risk of bodily injury, death, or property damage arising out of or related to the activities offered at Sleepy Hollow Sports Park. I assume full responsibility for any risk of bodily injury, death or property damage arising out of or related to the activities offered at Sleepy Hollow Sports Park whether caused by the negligence of Sleepy Hollow Sports Park, its owners, agents, employees, volunteer staff, equipment manufacturers, distributors or otherwise.

In consideration of being permitted to participate in the activities (CT) offered at Sleepy Hollow Sports Park I hereby agree to indemnify and save and hold harmless Sleepy Hollow Sports Park, its owners, agents, employees, volunteer staff, equipment manufacturers, distributors from any loss, liability, damage, or cost they may incur arising out of claims generated while I participated in activities at Sleepy Hollow Sports Park whether caused by their negligence or otherwise.

In consideration of being permitted to participate in the activities (CT) offered at Sleepy Hollow Sports Park I agree that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by Sleepy Hollow Sports Park, its owners, agents, employees, volunteer staff, and equipment manufacturers and distributors, including negligent rescue operations and is intended to be as broad and inclusive as is permitted by Iowa law and that if any portion is held valid, it is agreed that the balance shall continue in full legal force and effect.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT AND INDUCEMENT, ASSURANCE, GUARANTEES OR WARRANTIES, EXPRESSED OR IMPLIED, BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
